

MOTION TO COMMIT

M____. _____ moves to commit the bill H.R. 1 to the Committee on Foreign Affairs with instructions to report the same back to the House forthwith with the following amendments:

Page 191, strike lines 23 through 25 and insert the following:

1 (a) SENSE OF CONGRESS.—It is the sense of Con-
2 gress that—

3 (1) the responsibility for ensuring the security
4 of the American people rests exclusively with the
5 Government of the United States and should not be
6 delegated in whole or in part to any international or-
7 ganization, agency, or tribunal or to the government
8 of any other country;

9 (2) the freedom of the Government of the
10 United States to act as it deems appropriate to en-
11 sure the security of the American people should not
12 be limited by, or made dependent upon, the act or
13 lack thereof, by any international organization,
14 agency, or tribunal or by the government of any
15 other country;

1 (3) the Constitution of the United States is the
2 supreme law of the land and cannot be subordinated
3 to, or superseded by, any act, or lack thereof, by any
4 international organization, agency, or tribunal or by
5 the government of any other country;

6 (4) in carrying out its responsibility for ensur-
7 ing the security of the American people, the Govern-
8 ment of the United States has sought and should
9 continue seek to enlist the cooperation and support
10 of international organizations, agencies, and tribu-
11 nals, including the United Nations and its affiliated
12 organizations and agencies, as well as the govern-
13 ments of other countries; but no act taken by the
14 Government of the United States regarding its re-
15 sponsibility to ensure the security of the American
16 people should be deemed to require authorization,
17 permission, or approval by any international organi-
18 zation, agency, or tribunal or by the government of
19 any other country; and

20 (5) consistent with the 9/11 Commission's rec-
21 ommendations, the President should strive to expand

Page 192, line 4, redesignate paragraph (1) as sub-
paragraph (A) and conform the indentation accordingly.

Page 192, strike lines 10 through 12.

Page 192, line 13, redesignate paragraph (3) as subparagraph (B) and conform the indentation accordingly.

Page 192, line 15, through page 193, line 5, redesignate paragraph (4) as subparagraph (C), and redesignate subparagraphs (A) and (B) as clauses (i) and (ii), and conform the indentation accordingly.

Page 193, strike lines 6 through 9.

Page 193, lines 23 to 24, strike “paragraph (4) of subsection (a)” and insert “subparagraph (C) of subsection (a)(5)”.

Page 194, lines 2 to 3, strike “paragraphs (1), (2), (3), and (5) of subsection (a)” and insert “subparagraphs (A) and (B) of subsection (a)(5)”.

Page 194, line 9, strike “(a)” and insert “(a)(5)”.
