## **Explanatory Notes:**

- 1. Resolution A/60/L.40 requests the Secretary General to provide a list of the top ten providers of assessed and voluntary financial contributions to the United Nations, based on the average annual contributions in the previous three calendar years. A central data collection mechanism will need to be created to systematically account for all financial contributions towards the UN system. For the purposes of this initial list, financial data from the following budgets has been obtained: UN assessed contributions (including Regular Budget, Peacekeeping operations, International Tribunals and Working Capital Fund), UN General Trust Funds, voluntary contributions to UNDP, UNHCR, UNICEF, WFP and UNFPA, as well as assessed contributions to ILO, WHO and FAO.
- 2. The selection of funds, agencies and programmes has been made on the basis of (1) the size of the respective budgetary allocations; (2) the fact that their mandates broadly relate to peacebuilding activities. Although a number of smaller funds and programmes are not included in this computation, their inclusion would not alter the determination of the top ten contributors since there is a significant gap of more than US\$ 400 million between the 10<sup>th</sup> and 11<sup>th</sup> position.
